**NOTICE OF CHARGES**

Take Notice that under the authority of the Director, as set forth in Division of Alcoholic Beverage Control Act, N.J.S.A 33:1-1, et seq; and the regulations promulgated pursuant thereto, the New Jersey Division of Alcoholic Beverage Control (“Division”) will seek to revoke plenary retail license XXXX-XX-XXX-XXX held by LIQUOR LICENSE, LLC, issued by Mayor and Council of City/town/Borough, Xxxxx County, for premises located at 123 Main Street, City/town, NJ XXXXX, for violations of the aforementioned statute and/or regulations. The Division hereby prefers the following charges and will seek the noted penalty to wit:

| 2. | In your license renewal application, corporate structure change application, transfer application or amendment to the foregoing filed on or about xxx, you failed to show or disclose certain material facts, or falsely or inaccurately responded to questions thereon, viz., xxxx, in violation of N.J.S.A. 33:1-25. | 10-day suspension |
| 3. | In your license application filed for the xxxx term, you failed to show and fully disclose that you had agreed to permit XXX to retain all or part of the profits and income from your licensed business; such evasion and suppression of material fact being in violation of N.J.S.A. 33:1-35                         | 30-day suspension |
| 4. | On or about xx/xx/xx, you sold or accepted delivery of alcoholic beverages to/from XXX not listed in the applicable Current Price List filled with the Division of Alcoholic Beverage Control, in violation of N.J.A.C. 13-2-24.6(a)6  | 15-day suspension |

On xxx, you the holder of a retail liquor license received from XXX, the holder of plenary wholesale license number xxx, alcoholic beverages for sale under terms or conditions or promotions not contained in the applicable Marketing Manual or Current Price List, viz., xxx, in violation of N.J.A.C. 13:2-23.24. 30-day suspension
6. In your license application or amendment to a license application filed on or about xx/xx/xx, you failed to show or disclose that XXX, a brewery, winery, distillery, rectifier, blender or wholesale licensee disqualified from having an interest in a liquor license, had an interest, directly or indirectly, in the license applied for or in the business to be conducted under said license in violation of N.J.S.A. 33:1-43(a). Revocation

**However due to the aggravating circumstances in this case, the Division will seek revocation of the license based upon the total circumstances.**

The licensee must enter a plea to the charges within 30 days of its receipt. Failure to do so will result, pursuant to N.J.A.C. 13:2-19.3(c), in the entry of a non-vult plea on your behalf and the Director upon certification by the Division may impose the penalty stated in this Notice of Charges without further notice.
